The Environment Agency should be contacted when the river Piddle needs clearing and / or is likely to flood local properties or the highway. Call 0800 80 70 60

There should be NO LONE WORKING under any circumstance. Water should not be entered unless absolutely necessary and as a last resort. If the water is entered there MUST always be one person on the bank.

The following risks have been identified and are being managed by the Puddletown Area Parish Council. The Flood Warden is the Team Leader for all organised events with volunteers, and should ensure all volunteers are made aware of the following:

				Volunteers should wear strong gloves to protect themselves. Volunteers should take extra care and be vigilant. Any glass and other sharps should be carefully removed from the river and suitably disposed of.

Children should not use tools or equipment unless they have been trained and have been given permission by their parent / carer. Check all tool heads are secure and handles are free from splinters and cracks prior to use. Volunteers to use the correct lifting/tool techniques and to take regular breaks and swapping tool tasks to reduce likelihood of injury.

It is vital that these volunteers are skilled and trained to drive and operate these vehicles. It is key that children are managed around the on-site vehicles.

Anti-bacterial/ microbial hand wash to be carried and used after contact with water, particularly before eating, drinking or smoking. 	Lyme disease	М	м	Lyme disease is a bacterial disease transmitted by animal ticks associated with rank vegetation. Sheep, deer and pheasants may act as hosts. Remove ticks from skin as soon as possible using tweezers, wear light-coloured clothing so that ticks are visible. Tuck trouser bottoms into socks so that ticks cannot attach or climb up the leg and make regular checks of skin and hair.
	Insect bites	М	L	Carry insect repellent, and sting relief. Cover as much body surface as possible with clothing. Move away from stinging insects slowly. Avoid using beauty products with strong perfumes prior to task to minimize attraction. Volunteers to check at the end of the day for any bites, stings and unwanted visitors on their skin. (safe removal of ticks https://www.nhs.uk/conditions/lymedisease)
	Plant and Fungi allergies and sting	Μ	L	All participants will be wearing PPE gloves to protect from plants when handling material. Advise participants in advance to wear long sleeved tops and long trousers to reduce nettle stings and grass rashes and cuts.
Highways	Muscular, bone or soft tissue damage	М	Н	Some work may take place near a road, of particular concern is where work is undertaken near to a blind bend or junction. The flood warden will assess each event / occasion and consider if traffic calming is required. For emergency work, the Environment Agency should be called, and their guidance followed.
